### 1. Title of the Practice - Social and Rural Internship

# Objective of the Practice -

- 1. To Prepare awareness amongst students for social and rural problems.

- 6. To present report to the concern guide and team.
- 7. To provide financial support from institute for selected idea of project after related presentation.

- 1. Increase in social connection with villages.
- 2. Increase in thinking capacity to solve the real-life problems of society.
- 3. Increase in problem-based learning.

# 2. Title of the Practice - Project Grant to College Students (PGCS) scheme

## Objectives of the Practice -

To motivate multidisciplinary, industry and society-based student's projects

### Context -

The final year students who makes good projects would be useful for society and industry may require some financial assistance. To fulfill their needs, institute had taken up initiative for financial support to some of the best project groups from every department.

#### The Practice -

- 1. Students, seeking project support under this scheme are required to submit proposal through proper channel before internal examination of 1st semester
- 2. Screening of submitted forms to be done by the R & D committee.
- 3. The presentation of project group is examined by External Examiners and Results of the sanctioned projects will be declared by 15 days after PGCS presentation.
- 4. PGCS scheme may provide financial assistance up to Rs. 30,000/- or actual expenditure whichever is less for the college students for project in various branches.
- 5. The completed projects shall be assessed and graded by a duly constituted expert committee by the college.

### Evidence of Success -

- 1. Increases best project ideas
- 2. Increase in student research publications
- 3. Conversions of projects into product
