
1.2. Establishment of Research and Development (R&D) cell


The R&D Cell comprises of the following members

2. Responsibilities

Following are the main responsibilities of R&D Cell

- To identify Research focus /Thrust areas for innovation and research for various departments.
- To motivate faculty members and students to conduct high quality research in their area of expertise.
- To conduct Institute's research and development training activities.
- To review and monitor achievements under the Research & Development.
- To publish papers in reputed national and international journal which are indexed in Science Citation Index, Web of Science, Scopus etc.
- To motivate faculty members to participate in various national and international conferences at reputed institutes.
- To motivate faculty members to submit research proposals at BARC, AICTE, DST and other funding agencies.
- Collaborate DYP CET with leading research institutes at national and international levels. Initiatives like joint international conferences, workshops, and research papers can also be undertaken to improve the overall research culture at Institute.
- To help students to complete research projects and participate in various research activities at National and International level.

- To improve consultancy and R&D activities at institute.
- To create awareness about ethics of research and publications in faculty members and students

3. Meeting Schedule

The meetings of R&D are scheduled at least three times in each semester. At the start of semester, middle of semester and at the end of semester. All members will be informed the dates of scheduled meeting and also dates of additional meetings if required.

4. Policies for Research and Developments

4.1 Paper Publication Policy

- Faculty should publish papers in **reputed refereed journals** which are indexed in WoS, SCI, SCOPUS and other good databases (List may be available at Department).
- Professor and Associate Professors should publish at-least two papers per year in reputed refereed journals (Indexed in **WoS, SCI, SCOPUS, PubMed**).
- Assistant Professors should publish at-least one paper per year in reputed refereed journals (Indexed in **WoS, SCI, SCOPUS, PubMed**).
- All faculty members who have completed Ph.D must submit at least one funding proposal every year to BARC, AICTE, DST and other funding agencies.
- Incentives for publications are mentioned in Section 5.

4.2 Policy for participation in National and International Conferences.

•Institute will provide financial support for faculty to participate in National and International conferences as per rules of Institute. Incentives for publication in conferences are mentioned in Section 5. Following are some important conditions for this:

- a) Conference should be hosted by reputed institute.

b) Conference proceedings must be published in SCOPUS database.

4.3 IPR Policy

Institute will provide financial support to faculty for filing Patent and Copyrights. Patent and Copyrights must be filed in the name of institute only. The incentives for IPR are mentioned in Section 5.

4.4 Research Policy for Students

- To motivate students' research, Institute will provide funds to final year projects under **Project Grant to College Students (PGCS) scheme**. For this R & D cell will form a team to evaluate students' projects at various departments. Student groups will get funds maximum up-to Rs. 50,000/- per project. The limit may exceed depending on the quality of projects.

4.5. Consultancy Policy


The purpose of Consultancy Policy is to enable faculty to provide information inputs sought by industry, Government departments and other academic/research organizations. The main objective here is to foster academic, industry and research interaction. Funds generate from consultancy will be distributed as 40:60 (40 % to Institute and 60 % to Faculty)

5. Policy on Incentives for Research and Publication


Details of the Policy

- Calendar year will be applicable for consideration of research incentive.
- It is mandatory to have DYP CET affiliation in publication /book / book chapter / monographs / patent / copyright / externally funded research project and presented/ invited talk/ session chaired in conferences.
- Research paper published in journals indexed in SCI, WoS and SCOPUS will only be considered for incentive.
- Research Publication Means: Original research article, review article, short communication.
- Final decision will be made by the committee.


The committee shall consist of following members:

1. Dr. A K Gupta (Executive Director) : Chairman
2. Dr. S D. Chede (Principal) : Member
3. Dr. S J Raykar (Dean R & D) : Member Secretary
4. Dr. C.D. Lokhande, Dean, CIR, DYPU : Member
5. Concerned HoD : Member
6. One Industrialist : Member

In case of any dispute the Chairman's (Executive Director) decision shall be final.

For each Research Publication, author/s will be given one time incentive based on quality of the Journal. The disbursement of incentive will be carried out as per Annexure-I.

B. Book/ Book Chapter/ Monograph

The e-book and hard copy books are considered for research incentive. The pocket books or booklets and books having less than 50 pages are not considered for research incentive.

I. For each Book (Reference or Text) authored/edited singly or jointly and published by International Publisher (McGraw Hills, Tayler Francis, Springer, Elsevier, CBS Publisher etc. or Apex bodies/Societies with ISBN (International Standard Book Number), the Authors/Editors will be given incentive maximum of Rs. 25,000/- (Disbursement of amount among authors/Editors as per Annexure-I). (From one author only one book will be considered for funding in an Academic Year).

II. For each Book (Reference or Text) authored/edited singly or jointly and published by DYP CET /National Publisher (McGraw Hills India, JP publisher, Springer India, Elsevier India, CBS Publisher etc. with ISBN, the Authors/Editors will be given incentive maximum of Rs. 15,000/- (Amount disbursement among authors/Editors as per Annexure-I). (From one author only one book will be considered for funding in an Academic Year).

III. For each Book (Reference or Text) authored/edited singly or jointly and published by Local/ Regional Publisher with ISBN, the Authors/Editors will be given incentive maximum of Rs. 10,000/- (Amount disbursement among authors/Editors as per Annexure-I). (From one author only one book will be considered for funding in an Academic Year).

IV. For each "Chapter/ monograph" in Book published by International Publisher with ISBN, the Author/s will be given one time incentive maximum of Rs. 10,000/- (Amount disbursement among author/s as per Annexure-I). From one author only one Chapter/monograph will be considered for funding in an Academic Year).

V. For each "Chapter/monograph" in Book published by National Publisher with ISBN, the author/s will be given one time incentive maximum of Rs. 8,000/- (Amount disbursement among author/s as per Annexure-I) (From one author only one Chapter/monograph will be considered for funding in an Academic Year).

C. Incentive for Sanctioned International/ National Projects

International / National Project/s funded by Government &/or private outside agencies Principal Investigator (PI) or Co- Principal Investigator/s (Co-PI)* together (in the ratio of 60:40 %) will be given one time (in first year of the project) 25% of total overhead amount as an incentive.

(*In case of Co-PI from multi institutional project, the Institute Share from the project will be considered).

D. Patent Granted

The incentive maximum of Rs. 50,000/- for International and maximum of Rs. 25,000/- for Indian Patent will be given for successfully granted patent. For more than one investigator, the disbursement of incentive will be as per Annexure-I.

E. Copyright

The incentive maximum of Rs. 10,000/- for each copyright will be given to DYP CET faculty.

F. Incentive for Presenting Paper in Conferences and for attending Seminars/ Symposium/ Workshop/ FDP etc.

Faculty presented paper (oral/poster) in International or National Conference are entitled to get T.A. as per existing rules plus registration fee on submission of true copy of the certificate. One International and One National Conference in one calendar year are permissible for individual faculty. Prior permission or approval (through proper channel) is mandatory to claim for incentive. T.A. as per existing rules plus registration fees for attending Seminars/ Symposium/ Workshop/ FDP etc. will be given on submission of true

copy of the certificate. One Seminar/ Symposium/ Workshop/ FDP etc in one calendar year are permissible for individual faculty.

For International Conference: Maximum amount will be 25,000/- (Registration + TA)

National Conference: Maximum amount will be 15,000/- (Registration + TA)

G. The incentive maximum of Rs. 5,000/- for each National and 10,000/- for International award/ recognition will be given to DYP CET faculty.

6. Research Work Seed Funds

To motivate and help faculty members to boost their research work, DYP CET will provide facility of SEED funds to projects of PG students and Faculty. Following are some of important conditions of Seed Funds.

- The **Patent and Copyrights** from project work must be in name of College
- At least **two SCOPUS indexed Journal papers** must be published from the Project
- Project should preferably from **Interdisciplinary areas**.
- Maximum Limit for Individual Department Project is Rs. 3 Lac
- Maximum limit for Interdisciplinary Project is **Rs. 5 Lac**.
- Faculty should apply for Seed funds in **prescribed format** available at Dean R & D office.

1. Publication

- For publication with Impact Factor

Paper published in journals (with no impact factor according only Journal Citation Report, Thomson Reuter indexing agency and Scimago Journal & Country Rank) indexed with Scopus/ Web of Science/ PubMed/ Indian Citation Index: Rs. 8,000/-

- For publication with Impact Factor

(Impact Factor according to only Journal Citation Report, Thomson Reuter indexing agency and Scimago Journal & Country Rank) indexed with Scopus/ Web of Science/ PubMed/ Indian Citation Index:


