
Resolution: Board approved the appointment of Principal, Prof. S. D. Chede.

Item No.3 Permanent affiliation of four courses received from Shivaji University, Kolhapur, for information

Discussion: Prof. S. D. Chede informed the board about Permanent Affiliation of four of the courses namely Architecture, Chemical Engineering, Computer Science and Engineering and

Electronics and Telecommunication Engineering by Shivaji University, Kolhapur. Hon'ble Chairman, suggested the principal to apply for permanent affiliation of remaining courses as early as possible.

Item No.4 AICTE approval received for two new courses for the academic year 2020-21, for information

Discussion: Prof. S. D.
